Report on the Members' Meeting: Nov'23

The first ever Members' Meeting was held in November 2023 and we had 24 registered members in attendance resulting in a quorate meeting. (A pretty good turnout!) An Update on the Waterways Portfolio

The high temperatures and long hours of sunlight at this time of the year has seen a proliferation in floating algae on the Marina canals, which, if one reads the comments on the various Marina sites, is unanimously found to be aesthetically displeasing and through which (in some places) water craft (e.g. pedallos, SUP boards, rowing dinghies, canoes and surf-skis) can make no headway. As such, a prime reason of most Marina residents for living here (aesthetically-pleasing water views and use of the canals for rowing, sailing and paddling) is denied. Furthermore, many comments on the various Marina sites are very angry ones and are not always aimed in the right direction.

In November, to much acclaim and fanfare, a brand new weed harvester (named 'The Cape Shoveller'), manufactured here in Cape Town, was launched by the Executive Mayor of the City. However, it is still not operational as it is first required to be commissioned by SAMSA before it is allowed to 'plough' up and down our waterways and Zandvlei, picking up the algae and excessive waterweed growth - i.e., doing the job it is meant to do. The question of.... is it coincidental that this lengthy period of commissioning has occurred during the Christmas holiday season, or, does it just take this long to have such a machine found to be OK to do the work for which it was built? The jury is out on that question!

The old weed harvester, the 'Kingfisher', remains in the Marina waters as a back-up to the "Cape Shovellor", but between breakdowns, the public and other holidays taken by the operator, allied to the fact that with the many bush fires occurring around the Western Cape, CoCT personal (including

the Kingfisher operator) are called away from their normal jobs to fight these fires, thus the number of days and working hours done by the Kingfisher during these summer months, has been minimal (one of the reasons why there is the proliferation of floating algae on our waterways and Zandvlei).

But it isn't all doom and gloom as the PICID has been informed that additional council personnel have been trained to operate the 2 harvesters throughout the harvesting season, i.e. the summer months. The algae and weed growth has meant that the water quality of the Marina canals and Zandvlei is very good. Water clarity is good, fish are spawning, fishers are recording good (catch-and-release) catches and the water fowl are in a good space (there are even Flamingos back in Zandvlei!).

Also on a positive note is that the 'Boss' of the Zandvlei Nature Reserve (all the Marina canals form part of said reserve, along with Zandvlei), Kyran Wright, who is a resident of the Marina, is passionate about our waterways and what is found on and in them and is constantly looking for ways to make and keep this area the 'best kept secret' of the Peninsula. Thank you, Kyran, for this passion and your dedication to the cause - we owe you big time!

On a sad note, Marina da Gama's foremost canoeist and surf-ski paddler and a multiple South African National Canoe Colours awardee, Graeme Solomon, suffered a stroke early in the New Year. Happily, medical treatment intervention is currently seeing him on the road to recovery in a South Peninsula Step-down facility. His positivity, grit and determination to get back to being a top-level paddler again is amazing and I'm sure that I speak for all Marina residents in wishing him (the Western Cape Canoe Association's most prolific winner of races for more than 20 years!), all the very best towards full recovery. "We're all backing you, Solly".

Feedback on Our Security Program

We are very happy to report that **our Security Camera network is now fully operation during load-shedding**. This is an outstanding achievement overcoming all the power-challenges we are faced with. Our camera network is in addition to the MDGA cameras installed at the entrance, which are also monitored by Deep Blue. The entrance cameras already have backup power supplied by one of our residents (Thank you!).

Furthermore, regarding the guarding program, the Management Team are satisfied that there is a good relationship with the Ithuba management and our concerns are taken seriously and actioned upon. Colin is in direct communication with the Operations Manager and the PICID finger is on our security pulse!

Since our CID started officially operating at the beginning of July 2023, fortunately, we have not had any serious security breaches or incidents. This certainly does not mean that we should reduce our vigilance. Please don't leave doors unlocked, or windows and gates unnecessarily open. These actions so often welcome unwanted guests into our properties, which can result in tragic consequences. It is incumbent on us all to notify the Ithuba control room (079 905 7633) and the PI Security WhatsApp group if suspicious activity or any emergency is taking place in our area.

Please bear in mind that the Marina is a Home Owners Association and our roads are public property. Anybody is entitled to come onto PI. All security can do is vet and challenge any suspicious people in an attempt to dissuade them from wandering our streets.

Regarding Our Open Spaces

Our Park Island gardening superstar, Cherry Giljam, has continued running with maintaining and improving our PICID Open Spaces. Together with our committee members, the first 2024 project was recently launched to plan a 'new look' for the entrance to Park Island (off Prince George drive). It is still in the planning stage of Phase One, with several ideas being considered to beautify the verges and garden spaces with selected FYNBOS! So keep an eye on this space and please support it fully!

I.E. these initiatives rely on the participation of all residents and to get involved you can

simply join your local gardening team who can do with your support to look after and beautify our open spaces.

Please remember to keep your dogs on leads & out of the flower beds at all times, and make sure all dog walkers pick up all their dog poo!
